In these T's & C's, we refer to the above promoter(s) as "the Landlord" and the entrants as "the Participant(s)" or "you."
<b>IMPORTANT INFORMATION</b>		
3.	<b><u>Eligibility:</u> Who may enter the Competition?"</b>	To enter the Competition, a Participants must be in possession of a valid South African identity document or passport.
